Introducing the AFWA LEAP Advisory Council, a unique opportunity for emerging leaders within the organization. This new effort was created by the AFWA National Board to ensure the voice of emerging leaders is heard and utilized in the organization.

#### **PURPOSE**

Provide AFWA with valuable input from emerging leaders to ensure AFWA meets the needs of all members.

- Advise AFWA Board on programs and services of interest to members 35 years of age and younger.
- Emphasize the importance of supporting AFWA and The Foundation with time, energy, connections and philanthropy.
- Contribute to AFWA's marketing through a variety of channels.
- Convey the mission and vision of AFWA.

#### TIME COMMITMENT

The LEAP Advisory Council would ultimately consist of 10 members age 35 or younger. For the 2015-2016 year, 5 members would be installed with a 2 year term. The next year an additional 5 members would be installed to serve a 2 year term. From the initial 5 members, a Chair will be appointed by AFWA's National President, thereafter, the chair will be elected by their own board for a one year term. This Chair will serve as an Ex-Officio member of the AFWA National Board of Directors. A current member of the AFWA Board of Directors will also serve on the LEAP Advisory Council as a Liaison each year. It is expected that members of the LEAP Advisory Council will attend the AFWA National Conference each year.

We are now accepting applications for the inaugural LEAP Council year. Beginning in July 2015, the LEAP Council will consists of 5 members. The Council is planned to expand to 10 members beginning in July 2016.

Requirements: LEAP Council Members shall be active members of the Accounting & Financial Women's Alliance, and shall be 35 years old or younger.
